ELIGIBILITY REQUIREMENTS AND INTERSCHOLASTIC ACTIVITIES

Interscholastic activities shall be defined and governed by the Alaska School Activities Association (ASAA). Interscholastic activities shall be available to students by special approval of the Board. All such activities require the prior approval of the principal and shall be properly supervised.

Academic Eligibility

- 1.) Kuspuk School District follows the minimum Academic Eligibility criteria required by Alaska School Activities Association (ASAA).
- 2.) There will be 8 eligibility periods in each school year. Eligibility checks will be at the middle and at the end of each quarter. The specific eligibility check dates will be determined by administration at the beginning of each school year.
- 3.) To be eligible, a student must have a 2.0 GPA at the eligibility check.
- 4.) An eligibility progress report will be given 4 school days before the eligibility check. Students will have until the eligibility check to become eligible.
- 5.) Students who are not eligible at the eligibility check will remain so until the next scheduled eligibility check.

Attendance Eligibility

A student must be in attendance the full day of any scheduled competition. This includes not being tardy on the day of travel or the day of competition. A student with one or more full day unexcused absences during the week before and the week of the competition will be ineligible to participate in extracurricular competitions and travel activities. A student with one or more days of out of school suspensions during the week of a competition. Five tardies (Late to school) has the same consequences as one unexcused absence.

Practice Eligibility

A student is eligible to attend and participate in practice as long as they attend school for at least half the school day and the portion that the student does not attend is considered an excused absence.
