



In August, the state Department of Education & Early Development announced our school's standing with regards to meeting federal requirements for Adequate Yearly Progress (AYP) for state tests taken in Spring 2012. The **George Morgan Sr. Senior High School did not meet AYP.**

Under No Child Left Behind (NCLB), each state sets AYP goals for the percent of students that must be proficient on the state tests (Standards Based Assessment or SBAs) each year. By 2014, the AYP goal is that 100% of the students will be proficient on language arts (reading & writing) and math. For 2011 – 2012, Alaska's AYP goals for the percent of students that score proficient or above were: **Language Arts – 82.88 % and Math – 74.57%**. In order to make AYP, each of the following subgroups of students must meet the AYP goals: ethnicity, economically disadvantaged, students with disabilities, and students with limited English language proficiency. Schools must also meet an additional requirement of graduation rate of 85% (if they have students who were scheduled for graduation) **OR attendance rate of 85%** (for schools with no students eligible for graduation).

At **George Morgan Sr. Senior High School**, performance of the following subgroups is being reported:

- The School As A Whole
- Alaska Native & American Indian
- Economically Disadvantaged
- African American
- Caucasian
- Students with Disabilities
- Asian
- Multi-ethnic
- Limited English Proficient
- Hispanic

The AYP goals will increase in future years until all students are required to be proficient in 2014. In addition to AYP, each school as a whole and the subgroups must meet a participation rate for testing. 95% of students in a school must participate in testing for the school to meet AYP. We are pleased that **George Morgan Sr. Senior High School did meet AYP for participation.**

For 2011-2012, **George Morgan Sr. Senior High School did meet Adequate Yearly Progress for graduation with a graduation rate of 45.45%. Although the graduation rate was well below the required 85%, the school did show improvement from the previous year, thus meeting AYP for Graduation rate.** The graduation rate is figured based on a formula that takes into account the class who entered high school in the 9th grade, dropouts from 9th-12th grade, and the number of seniors that graduated with a regular diploma from that initial 9th grade class.

For 2011-2012, **George Morgan Sr. Senior High School overall did not meet Adequate Yearly Progress for Mathematics but did meet Adequate Yearly Progress for Language Arts through Safe Harbor.** The **Safe Harbor** provision under NCLB means that even though one of our subgroups of students did not meet the stated AYP goals, because the number of students who were not proficient decreased by at least ten percent from the prior year, the "safe harbor" provision allows the school to meet AYP. This helped us make AYP in Language Arts.

Following is a summary of the student groups and the percentage of proficient students:

For other subgroups the proficiency percentage was not reported because of the small number tested.

Because **George Morgan Sr. Senior High School** is a Title I school and has not made Adequate Yearly Progress (AYP) for 6 years, we will be designated as a Level 5, year 6 School in Restructuring for the 2012 – 2013 school year. We are required to continue to review and revise our School Improvement Plan to identify ways to strengthen instructional support programs for our students and submit our plan to the district for approval. Our school will be focusing on ways to close achievement gaps and bring every student to proficiency in reading, writing and math. Parents and community members are invited and encouraged to be a part of this process. If you are interested in participating in the School Improvement plans, please contact your principal.

Qualifying students will be offered supplemental educational services (free tutoring) targeted at helping each child reach state academic standards. Parents of qualifying students will be receiving a special letter providing more information about the free tutoring that may be available to their child.

In addition, the district will continue to implement a previously developed restructuring plan for alternative governance for our school.

Our goal is 100% proficiency for all students. The entire staff of **George Morgan Sr. Senior High School** is behind this goal and the efforts of parents, students and the district office to make it happen.

District level AYP is not yet available. Specific information on how our students scored district wide will be included in the District Report Card to the Public which will be sent in the next few weeks.
